- 二、經本管道錄取之本校四技學士班一年級外籍新生,第一學期學雜費減半,之後若前一 學期學業成績及操行成績均達 80 分以上,則次學期學雜費減免一半,至二年級下學 期為止。
- 三、經本管道錄取之本校二技學士班三年級外籍新生,第一學期學雜費減半,之後若前一學期學業成績及操行成績均達80分以上,則次學期學雜費減免一半,至三年級下學期為止。

- **II.** Foreign students who are admitted the four-years bachelor degree by school, tuition and miscellaneous fees will be reduced by half in the first semester. The previous semester academic performance and conduct grade must both reach 80 points. Next semester tuition and miscellaneous fees will be reduced by half, until the second semester of the second year.
- **III.** Foreign students who are admitted the two-years bachelor degree by school, tuition and miscellaneous fees will be reduced by half in the first semester. The previous semester academic performance and conduct grade must both reach 80 points. Next semester tuition and miscellaneous fees will be reduced by half, until the second semester of the second year.

# 參、申請資格 Eligibility

The eligibility of application is regulated by "Regulations Regarding International Students Undertaking Studies in Taiwan" issued by Ministry of Education (MOE). For the up-to-date information regarding MOE regulations, please visit:

- 一、 學歷資格 Educational qualifications:
  - 1. 四年制學士班須持高中以上學校畢業學歷或與我國學制相當之同等學力資格者。The applicant should hold a valid senior diploma or has the qualification to be equivalent to the academic qualifications of Taiwan's academic system.
  - 2. 二年制學士班須持有專科以上學校畢業學歷或與我國學制相當之同等學力資格者。 The applicant should hold an associate bachelor degree diploma or has the qualification to be equivalent to the academic qualifications of Taiwan's academic system.

二、語言能力基準:本校教學以華語授課為主。申請者具華語文能力測驗(TOCFL)2級或以上之能力證明。

Language proficiency benchmark:

Classes will be instructed mainly in Chinese. The applicant should hold a Chinese language proficiency proof which is equivalent to TOCFL A2 or above.

### 學生國籍認定 Student Nationality Recognition

- 1. 具外國國籍(註 1) 且未曾具有中華民國國籍,於申請時並不具僑生資格者。 An individual of the nationality, who has never held nationality status from the Republic of China ("R.O.C.") and who does not possess an overseas Chinese student status at the time of their application.
- 2. 具外國國籍且符合下列規定,於申請時並已連續居留(註 2)海外(註 3)六年(註 4)以上者。 An individual of the foreign nationality, pursuant to the following requirements and who has resided overseas continuously for no less than 6 years is also qualified to apply for admission under this regulation.
  - A. 申請時兼具中華民國國籍者,應從未曾在臺設有戶籍。 An individual who also is a national of the R.O.C., but does not hold nor has had a household registration in Taiwan.
  - B. 申請前曾兼具中華民國國籍,於申請時已不具中華民國國籍者,應自內政部許可喪失中華民國國籍之日起至申請時已滿八年。
    An individual who also was a national of the R.O.C. but has no R.O.C. nationality at the time of their application shall have an annulled status regarding their R.O.C. nationality for no less than 8 years after an annulment of R.O.C. nationality by the Ministry of the Interior.
  - C. 二款均未曾以僑生身分在臺就學,且未於當學年度接受海外聯合招生委員會分發。 Regarding individuals mentioned in the preceding 2 subparagraphs, they must not have studied in Taiwan as an overseas Chinese student nor received placement permission during the same year of the application by the University Entrance Committee for Overseas Chinese Students.
- 3. 依教育部合作協議,由外國政府、機構或學校遴選來臺就學之外國國民,其自始末曾在臺設有戶籍者,經主管教育行政機關核准,得不受前二項規定之限制。
  According to the Education Cooperation Framework Agreement, a foreign national who was selected by a foreign government, organization, or school, and does not hold a household registration from the time of their birth is not subject to the limitations as prescribed in the preceding 2 paragraphs after receiving the approval from the authorized educational government agencies. If the calculated calendar year is not one complete calendar year, their stay in Taiwan should not exceed 120 days within the calculated calendar year period.
- 註 1:申請資格係依據教育部「外國學生來臺就學辦法」之規定,辦法如有修正,以教育部最新公告為準。以上各項說明若有未盡事宜,悉依相關法令規定及本校招生委員會決議辦理。 Application eligibility is based on the "Regulations Regarding International Students Undertaking Studies in Taiwan" of the Ministry of Education. When the regulations are revised, the latest version published by the Ministry of Education prevails. The term"continuously" means that an individual may stay in Taiwan for no more than a total of 120 days per calendar year.

Overseas as prescribed is limited to countries or regions other than Mainland China, Hong Kong and Macau.

註 4: 所定六年、八年,以擬入學當學期起始日期(2月1日或8月1日)為終日計算之。

The period of six years or eight years mentioned above should be calculated by using the start date of the semester (February 1 or August 1) in which an applicant wishes to enroll as the end date of the period.



- 3. 修業年限:依本校學則辦理,大學部以四年為原則,未能修足應修學分者,至多得延長 2 年修業年限。Duration of Study: In accordance with the Meiho university's academic regulations, the standard duration for undergraduate programs is four years. Students who fail to complete the required credits within this period may extend their study duration by up to two additional years.

  - VIII.Language proficiency benchmark: Test of Chinese Language Proficiency Test (TOCFL) Level A2 or above (included) from National Chinese Language Test Promotion Working Committee, or other Chinese language test listening and reading certificates of the same level.

The admission of international students will first be evaluated by each corresponding department according to their own admission criteria. A preliminary admission list will be compiled and submitted to the Admission Committee for further review approved. The Admission list is announced and email to students by the Office of International and Cross-Strait Affairs.

# 拾壹、報到與註冊入學/ Registration and Enrollment Registration

- 一、本校確認錄取生有入學意願後,即由國際及兩岸事務處將入學許可以電子郵件方式及紙本方式寄送給新生。錄取生應依寄發錄取通知之規定,在指定期限前回覆入學意願辦理通訊報到。逾期未完成通訊報到者,以自願放棄錄取資格論,其缺額由已登記遞補之備取生依序遞補。
- 二、開學:2025年9月中旬 錄取生應依入學通知書之規定辦理報到註冊手續,並繳驗護照、經我國駐外館處、行政院 設立式长定之機構式系式之足問團豐驗級之異對終書、真中式結單及健康於本正本(於驗

設立或指定之機構或委託之民間團體驗證之畢業證書、高中成績單及健康檢查正本(檢驗 後歸還),始得註冊入學。未依規定日期補繳或逾期未報到即以自願放棄入學資格論。

- 三、根據教育部規定,外國學生註冊入學時,未逾該學年第一學期修業期間三分之一者,於當 學期入學;已逾該學年第一學期修業期間三分之一者,於第二學期或下一學年註冊入學。
- 四、 外國學生接獲本校入學許可後,須提出接獲錄取通知後3個月內之健康檢查紀錄。外國學 生來臺註冊後,仍需配合參加本校新生體檢。
- I. Once the enrollment is confirmed, admission certificate will be sent to all new students thru e-mail and mail. Admitted students are required to complete online registration before the stated deadline online. Students failing to complete the online New Student Confirmation Form will be regarded as having voluntarily forfeited their admission status. Vacancies resulting from students who have forfeited their admission will be filled in the order of the names as they appear on the wait list.
- II. School starts on Mid-September, 2025.
  - Students need to submit passport, senior diploma, transcripts and health certificate (originals) officially verified by a Taiwan overseas representative office, or verified by an institute established or appointed by, or through a private agency commissioned by the Executive Yuan before completing registration. (Please note: photocopied documents will not be accepted; all original documents will be returned after inspection).
- III. According to the rules of MOE, foreign students can only be admitted before 1/3 of the semester time, or being admitted the next semester.
- IV.Once receive the Admission Certificates, all students need to provide their health examination report within 3 months. All new students also need to have a physical examination at school after registration.

- (1) 於註冊開學日(含)以前,申請休、退學者,免繳費,已收費者,全額退費。
- Apply for suspension or withdrawal before the registration date (inclusive), no payment required; full refund for those charged.
- (2) 於註冊開學日次日起至第六週期間,申請休、退學者,學雜費按週數比例退還。

From the day after the registration start date to the sixth week, those who apply for leave or withdrawal will have their tuition and miscellaneous fees refunded in proportion to the number of weeks.

- (3) 於註冊開學日後第七週起至第十二週期間,申請休、退學者,學雜費退還三分之一。
- From the seventh week to the twelfth week after the registration start date, one-third of the tuition and miscellaneous fees will be refunded to those who apply for leave or withdrawal.
- (4) 於註冊開學日後第十三週(含)以後,申請休、退學者,所繳學雜費不予退還。

After the thirteenth week (inclusive) of the registration start date, the tuition and miscellaneous fees paid is not refundable to those who apply for leave or withdrawal.

## 拾參、其他申請注意事項 Relevant Information

- 一、報名時繳交之「畢業證書」及「歷年成績單」,除海外臺灣學校所發者外,應依教育部 「大學辦理國外學歷採認辦法」規定辦理。
- 二、依教育部規定,凡曾經入學學校以操行、學業成績不及格或因犯刑事案件經判刑確定致遭 退學者,不得再向本校申請入學。若違反此規定並經查證屬實者,取消其入學資格。
- 三、已報名或錄取之學生,如經發現申請資格不符規定或所繳交之證件有變造、偽造、假借、 冒用等不實情事者,未入學者即取消錄取資格;已入學者開除學籍,亦不發給任何學歷證 明;如將來在本校畢業後始發現者,除勒令繳銷其學位證書外,並公告取消其畢業資格。
- 四、註冊時,新生應檢附:已於國外投保、自入境當日起至少6個月效期之醫療及傷害保險。
- 五、外國學生就學期間在臺設戶籍登記、戶籍遷入登記、歸化或回復中華民國國籍者,喪失外國學生身分,應予退學處分。
- 六、本簡章中文版與翻譯版語意有所差異時,依中文版為主。如有未盡事宜,依相關法規及本 校招生委員會決議辦理。
- I. Diplomas and academic records issued by foreign schools should meet the requirement of MOE.
- II. Students who had a criminal record or ever being expelled by the University cannot apply, and their admission will be revoked if being found.
- III. Students who use faked documents in their application will be denied admission, and those who are admitted will not be offered a diploma. For those who graduated, their diplomas will be revoked.
- IV. Newly admitted students should submit valid health/accident insurance certificates effective at least for 6 months on the date of their arrival.
- V. Students who apply for household registration or acquire ROC citizenship, subsequently lose their foreign student identity will be expelled by the university.
- VI. The Chinese version always apply, should there be any discrepancy between the Chinese and English versions, Matters not set forth explicitly in the brochure shall be dealt with in accordance with MU Guidelines of International Students Admission and settled by the International Student Admission Committee.
