- 二、經本管道錄取之本校四技學士班一年級外籍新生，第一學期學雜費減半，之後若前一學期學業成績及操行成績均達 80 分以上，則次學期學雜費減免一半，至二年級下學期為止。
- 三、經本管道錄取之本校二技學士班三年級外籍新生，第一學期學雜費減半，之後若前一學期學業成績及操行成績均達 80 分以上，則次學期學雜費減免一半，至三年級下學期為止。

- II. International freshmen admitted to the University's four-year undergraduate (four-year technical) programs through this admission channel shall receive a 50% reduction in tuition and miscellaneous fees for the first semester. Thereafter, if both the academic performance and conduct grades of the previous semester reach 80 points or above, the tuition and miscellaneous fees for the following semester will be reduced by 50%, up to and including the second semester of the sophomore year.
- III. International students admitted through this admission channel to the University's two-year undergraduate (two-year technical) programs as third-year entrants shall receive a 50% reduction in tuition and miscellaneous fees for the first semester. Thereafter, if both the academic performance and conduct grades of the previous semester reach 80 points or above, the tuition and miscellaneous fees for the following semester will be reduced by 50%, up to and including the second semester of the junior year.

參、申請資格 Eligibility

Eligibility requirements are governed by the Ministry of Education's "Regulations Regarding International Students Undertaking Studies in Taiwan." 一、學歷資格 Academic Qualifications

1. 四年制學士班須持高中以上學校畢業學歷或與我國學制相當之同等學力資格者。Applicants to the Four-Year Bachelor's Program must hold a high school diploma or higher, or possess an equivalent qualification comparable to the education system of the Republic of China (Taiwan).
 2. 二年制學士班須持有專科以上學校畢業學歷或與我國學制相當之同等學力資格者。Applicants to the Two-Year Bachelor's Program must hold a junior college diploma or higher, or possess an equivalent qualification comparable to the education system of the Republic of China (Taiwan).
- 二、語言能力基準：本校教學以華語授課為主。申請者具華語文能力測驗(TOCFL)2級(含)以上之能力證明。Language Proficiency Requirements: Instruction at our university is primarily conducted in Mandarin Chinese. Applicants are required to provide proof of Chinese language proficiency at Level 2 or above on the Test of Chinese as a Foreign Language (TOCFL).

學生國籍認定 Student Nationality Verification

1. 具外國國籍(註 1) 且未曾具有中華民國國籍，於申請時並不具僑生資格者。
An applicant who holds foreign nationality, has never held nationality of the Republic of China (R.O.C.), and does not possess overseas Chinese student status at the time of application.
 2. 具外國國籍且符合下列規定，於申請時並已連續居留(註 2)海外(註 3)六年(註 4)以上者。
An applicant who holds foreign nationality and meets one of the following conditions, and who has resided overseas continuously for six (6) years or more at the time of application, is also eligible to apply under this regulation.
 - A. 申請時兼具中華民國國籍者，應從未曾在臺設有戶籍。
An applicant who also holds R.O.C. nationality at the time of application must have never established household registration in Taiwan.
 - B. 申請前曾兼具中華民國國籍，於申請時已不具中華民國國籍者，應自內政部許可喪失中華民國國籍之日起至申請時已滿八年。
An applicant who previously held R.O.C. nationality but no longer holds such nationality at the time of application must have been approved by the Ministry of the Interior to renounce R.O.C. nationality for at least eight (8) years prior to the application date.
 - C. 二款均未曾以僑生身分在臺就學，且未於當學年度接受海外聯合招生委員會分發。
Applicants described in Subparagraphs A and B must not have previously studied in Taiwan as overseas Chinese students, and must not have been assigned or placed by the University Entrance Committee for Overseas Chinese Students in the same academic year as the application.
 3. 依教育部合作協議，由外國政府、機構或學校遴選來臺就學之外國國民，其自始未曾在臺設有戶籍者，經主管教育行政機關核准，得不受前二項規定之限制。
Pursuant to education cooperation agreements approved by the Ministry of Education, a foreign national who is selected by a foreign government, organization, or educational institution to study in Taiwan and who has established household registration in Taiwan at any time may, upon approval by the competent educational authority, be exempt from the restrictions set forth in the preceding two paragraphs.
- 註 1：申請資格係依據教育部「外國學生來臺就學辦法」之規定，辦法如有修正，以教育部最新公告為準。以上各項說明若有未盡事宜，悉依相關法令規定及本校招生委員會決議辦理。
Application eligibility is determined in accordance with the “Regulations Regarding International Students Undertaking Studies in Taiwan” promulgated by the Ministry of Education. In the event of any amendments to the regulations, the latest version announced by the Ministry of Education shall prevail. Any matters not specified herein shall be handled in accordance with relevant laws and regulations and the resolutions of the University Admissions Committee.
- 註 2：所稱連續居留，指外國學生每曆年在國內停留期間不得逾一百二十日。
For the purpose of these regulations, “continuous residence” means that an international student may not stay in Taiwan for more than a total of one hundred and twenty (120) days in any calendar year.
- 註 3：所稱海外，指大陸地區、香港及澳門以外之國家或地區。
For the purpose of these regulations, “overseas” refers to countries or regions other than Mainland China, Hong Kong, and Macau.
- 註 4：所定六年、八年，以擬入學當學期起始日期(2 月 1 日或 8 月 1 日)為終日計算之。
The aforementioned six-year and eight-year periods shall be calculated with the commencement date of the intended semester of enrollment (February 1 or August 1) as the end date.

1. 本學士班以中文授課，應修畢 128 學分 This bachelor's program is taught in Chinese and requires completion of 128 credits for graduation. 2. 申請人可同時申請 2 個以上系所，惟同獲錄取時，僅能選擇其中 1 個系所報到及註冊入學。Applicants may apply to two or more departments/programs. However, if admitted to more than one program, only one program may be selected for enrollment and registration. 3. 修業年限(四技)：依本校學則辦理，大學部以四年為原則，未能修足應修學分者，至多得延長 2 年修業年限。Duration of Study (Four-Year Technical Bachelor's Program): In accordance with the University's academic regulations, the standard duration of study for undergraduate programs is four years. Students who are unable to complete the required credits within this period may apply for an extension of up to two additional years. 4. 護理系的學士班(二技)：以中文授課，應修畢 72 學分。依本校學則辦理，修業年限以二年為原則，華語文課程(含測驗)不列入計算，未能修足應修學分者，至多得延長 2 年修業年限。Bachelor's Program in Nursing (Two-Year Technical Bachelor's Program): The program is taught in Chinese, and students are required to complete a total of 72 credits. In accordance with the University's academic regulations, the standard duration of study is two years. Chinese language courses (including related tests) are not counted toward the program credits. Students				

who are unable to complete the required credits within the standard period may apply for an extension of up to two additional years.

*** 報名注意事項 Application Notes:**

1. 須是授予副學士資格的護理專科以上學校的畢業生。Applicants must be graduates of nursing junior colleges or higher institutions that award an Associate Degree or above.
2. 須提供歷年修課的課程大綱、內容及學分(學時)數，經本系招生委員會審議通過，始得報名。Applicants are required to submit course syllabi, course descriptions, and the number of credits (or contact hours) for all previously completed courses. Applications will be accepted only after review and approval by the Department's Admissions Committee.
3. 外國學生於本班畢業後，不具備報考台灣護理師國家考試之資格。Foreign students who graduate from this program are not eligible to take Taiwan's National Nurse Licensing Examination after graduation.
4. 外國學生得以「入學前」畢業的護理學校的相關資料，報考「台灣的護理師國家考試」。Foreign students may apply to take Taiwan's National Nurse Licensing Examination based on nursing education credentials obtained prior to admission to this program.
5. 外國學生的畢業的學校，必須是符合教育部採認規定的國外專科以上學校的護理相關科系畢業；另外再依照考選部公告的簡章規範進行申請，例如：入學前取得的護理學校的畢業證書、在學歷年成績與實習證明，在經中華民國外交部或其駐外館處認證後，得為佐證資料。The nursing school from which a foreign student graduated must be a nursing-related program at a foreign junior college or higher institution recognized by Taiwan's Ministry of Education. Applications must also comply with the regulations announced by the Ministry of Examination. Required documents (such as pre-admission nursing diplomas, academic transcripts, and internship certificates) must be authenticated by the Ministry of Foreign Affairs of the Republic of China (Taiwan) or its overseas missions to serve as supporting evidence.
5. 修畢本學士班(二技)的學生，若欲報考台灣護理師國家考試，需額外加修大學部各科護理學實習共 20 學分/60 學時，且不列入畢業學分。Students who complete this Two-Year Technical Bachelor's Program and wish to apply for Taiwan's National Nurse Licensing Examination are required to take an additional 20 credits / 60 contact hours of undergraduate nursing practicum courses. These credits are not counted toward graduation requirements.

The statement must include the account holder's name and show a current balance of at least USD 3,300 (or NTD 100,000).
If the financial statement is not in the applicant's name, an Affidavit of Support must be provided.

- 二、本校外國學生之申請入學，由各系（所）依其訂定之入學標準進行初審，招生委員會就初審通過名冊予以複審核定，錄取名單由本校國際及兩岸交流處公告並以電子郵件通知考生。

Review and Admission Process: Applications submitted by international students are first reviewed by the respective departments or graduate institutes in accordance with their established admission criteria. The Admissions Committee then conducts a secondary review and approves the list of qualified applicants. The final list of admitted students will be announced by the Office of International and Cross-Strait Affairs and applicants will be notified by email.

拾、申訴程序 Appeal Procedures

考生對於本項招生事項有疑義或有違反性別平等原則之申訴案，應於成績複查截止日起一週內提出，以書面具名向本校招生委員會提出申訴，逾期不受理。

Applicants who have questions regarding this admission process or wish to file a complaint related to a violation of gender equality principles must submit a written and signed appeal to the University's Admissions Committee **within one week** after the grade review deadline. Late submissions will not be accepted.

拾壹、報到與註冊入學 Enrollment and Registration

- 一、本校確認錄取生有入學意願後，即由國際及兩岸交流處將入學許可以電子郵件方式及紙本方式寄送給新生。錄取生應依寄發錄取通知之規定，在指定期限前(2026年8月8日前)回覆入學意願辦理通訊報到。逾期未完成通訊報到者，以自願放棄錄取資格論，其缺額由已登記遞補之備取生依序遞補。
- 二、開學：2026年9月中旬
錄取生應依入學通知書之規定辦理報到註冊手續，並繳驗護照、經我國駐外館處、行政院設立或指定之機構或委託之民間團體驗證之畢業證書、高中成績單及健康檢查正本(檢驗後歸還)，始得註冊入學。未依規定日期補繳或逾期未報到即以自願放棄入學資格論。
- 三、根據教育部規定，外國學生註冊入學時，未逾該學年第一學期修業期間三分之一者，於當學期入學；已逾該學年第一學期修業期間三分之一者，應於第二學期或下一學年註冊入學。
- 四、外國學生接獲本校入學許可後，須提出接獲錄取通知後3個月內之健康檢查紀錄。外國學生來臺註冊後，仍需配合參加本校新生體檢。

- I. Admission Permit and Correspondence Enrollment: Once the University confirms an admitted student's intention to enroll, the Office of International and Cross-Strait Affairs will issue the admission permit to the new student by both email and postal mail. Admitted students must confirm their intention to enroll and complete correspondence enrollment by the designated deadline (**no later than August 8, 2026**), in accordance with the instructions stated in the admission notice. Failure to complete correspondence enrollment by the stated deadline will be regarded as a voluntary forfeiture of admission, and the resulting vacancy will be filled by wait-listed applicants in order of priority.

- II. Semester Commencement and On-Site Registration: The semester will commence in **mid-September 2026**. Admitted students must complete registration procedures in accordance with the instructions stated in the admission notice and present the following original documents for verification (all originals will be returned after inspection): passport; graduation certificate; senior high school transcript; and health examination report, all of which must be authenticated by an ROC overseas mission, or by an institution established or designated by the Executive Yuan, or by a private organization commissioned by the Executive Yuan. Students who fail to submit the required documents or complete registration by the specified deadline will be deemed to have voluntarily forfeited their admission.
- III. Registration Timing in Accordance with Ministry of Education Regulations: According to Ministry of Education regulations, international students who complete registration before one-third of the instructional period of the first semester of the academic year has elapsed shall be admitted in that semester. Those who complete registration after one-third of the instructional period has elapsed shall be admitted in the second semester or the following academic year.
- IV. Health Examination Requirements: After receiving the admission offer, international students must submit a health examination report issued within three months of the admission notification. After arrival in Taiwan and completion of registration, all international students are still required to participate in the university's freshman health examination.

- 一、每學期費用：收費標準以新台幣計算。學生應於開學前繳清當學期之各項費用始得入學。 Fees Per Semester: All fees are calculated in New Taiwan Dollars (NTD). Students must pay all required fees for the semester in full before the start of classes in order to be eligible for enrollment.

From the thirteenth week (inclusive) onward after the registration start date:

No refund of tuition and miscellaneous fees will be granted to students who apply for suspension or withdrawal.

- II. In accordance with Ministry of Education regulations, applicants who were previously dismissed from an institution due to unsatisfactory conduct or academic performance, or expelled due to a finalized criminal conviction, are not eligible to apply for

- admission. Any admission granted in violation of this regulation will be revoked upon verification.
- III. If an applicant or admitted student is found to have submitted forged, altered, falsified, borrowed, or misrepresented documents, the following actions shall apply:
 - i. Applicants who have not yet enrolled will have their admission revoked.
 - ii. Enrolled students will be expelled, and no academic credentials will be issued.
 - iii. If discovered after graduation, the degree certificate shall be revoked, and the graduation qualification shall be publicly annulled.
 - IV. Upon registration, newly admitted students must submit proof of medical and accident insurance purchased overseas, valid for at least six months from the date of entry into Taiwan.
 - V. During the period of study, foreign students who establish household registration in Taiwan, transfer household registration, acquire ROC nationality, or restore ROC nationality shall lose their foreign student status and will be dismissed from the University.
 - VI. In the event of any discrepancy between the Chinese version and the translated version of this brochure, the Chinese version shall prevail. Any matters not specified herein shall be handled in accordance with relevant laws and regulations and resolutions of the University Admissions Committee.
