申請資格 Eligibility

壹、外國學生身分(International Student Status)

申請人需符合「外國學生來臺就學辦法」規定。

Our admissions criteria are based on MOE Regulations Regarding International Students Undertaking Studies in Taiwan.

- 一、具外國國籍且未曾具有中華民國國籍，未曾以僑生身分在臺就學，且未於申請入學當學年度依僑生回國就學及輔導辦法經海外聯合招生委員會分發者。

Individuals of foreign nationality, and have never held nationality status from the Republic of China ("R.O.C.") and do not possess overseas Chinese student status at the time of their application, are qualified to apply for admission under this regulation.

- 二、具外國國籍且符合下列規定，於申請時並已連續居留海外六年以上者。

An individual of foreign nationality, pursuant to the following requirements and have resided overseas for more than 6 consecutive years are also qualified to apply for admission under this regulation.

- (1) 申請時兼具中華民國國籍者，應自始未曾在臺設有戶籍。

Individuals who also are nationals of the R.O.C., but do not hold nor have had a household registration in Taiwan.

- (2) 申請前曾兼具中華民國國籍，於申請時已不具中華民國國籍者，應自內政部許可喪失中華民國國籍之日起至申請時已滿八年。

Individuals who also were nationals of the R.O.C. but have no R.O.C. nationality at the time of their application shall have an annulled status regarding their R.O.C. nationality for no less than 8 years after an annulment of R.O.C. nationality by the Ministry of the Interior.

- (3) 前二款均未曾以僑生身分在臺就學，且未於當學年度接受海外聯合招生委員會分發。Regarding individuals mentioned in the preceding 2 subparagraphs, they must not have studied in Taiwan as an overseas Chinese student nor received placement permission during the same year of the application by the University Entrance Committee for Overseas Chinese Students.

- (4) 本款所定 6 年，以擬入學當學期起始日期（2 月 1 日或 9 月 1 日）為終日計算之。The six-year period as prescribed in Paragraph 2 shall be calculated using the starting date of the semester (Feb. 1st or Sep. 1st) as the designated end date.

- (5) 上述所稱海外，係指東協十國、南亞六國及紐西蘭、澳洲等新南向國家或地區。所稱連續居留，指外國學生每曆年在國內停留期間不得逾 120 日。連續居留海外採計期間之起迄年度非屬完整曆年者，以各該年度之採計期間內在國內停留期間未逾 120 日予以認定。但符合下列情形之一且具相關證明文件者，不在此限；其在國內停留期間，不併入海外居留期間計算：

The term "overseas" mentioned in the above sections is limited to 10 Southeast Asian countries and 6 South Asian countries. The phrase "continuously reside overseas" means that an individual may stay in Taiwan for no more than a total of 120 days per calendar year. The exceptions to these stipulations are as follows (Please note that these exceptions must be supported by written documentation):

- (a) 就讀僑務主管機關舉辦之海外青年技術訓練班或教育部認定之技術訓練專班。Individuals who attended overseas youth training courses organized by the Overseas Chinese Affairs Council or technical training classes accredited by the Ministry of Education (hereafter referred to as the "Ministry")

(b) 就讀教育部核准得招收外國學生之各大專校院華語文中心，合計未滿 2 年。
Individuals who attended a Mandarin Chinese language center at a university or college in Taiwan for no more than 2 years. Please note: the educational institution must be Ministry accredited.

(c) 交換學生，其交換期間合計未滿 2 年。
Individuals who have studied in Taiwan as exchange students for no more than 2 years.

(d) 經中央目的事業主管機關許可來臺實習，實習期間合計未滿 2 年。
Individuals who worked as interns for no more than 2 years. Please note: internships must have been authorized by a central government agency.

三、具外國國籍，兼具香港或澳門永久居留資格，且未曾在臺設有戶籍，申請時於香港、澳門或海外連續居留滿六年以上，並符合下列規定者：
Foreign passport holders with concurrent Hong Kong or Macau permanent residence should never have been registered as part of a household in Taiwan, and have continually resided in Hong Kong, Macau, or another foreign country (overseas) for no less than 6 years at the time of application.

(1) 所稱連續居留，指每曆年在國內停留期間，合計未逾 120 日。但符合前款第五目第一小目至第四小目所列情形之一且具相關證明文件者，不在此限；其在國內停留期間，不併入前項連續居留期間計。

The term “reside overseas continuously” mentioned in the preceding paragraph means an individual may stay in Taiwan for no more than a total of 120 days per calendar year. However, such a term may be exempt, if any of the conditions prescribed in Subparagraphs 1 through 4, Paragraph 5 of the previous Article applies and is supported with written proof, and the said domestic length of stay shall be excluded from the overseas length of residency.

(2) 所定 6 年，以擬入學當學期起始日期（2 月 1 日或 9 月 1 日）為終日計算之。
The six-year period shall be calculated using the starting date of the semester (Aug. 1st or Feb. 1st) as the designated end date.

(3) 所稱海外，指大陸地區、香港及澳門以外之國家或地區。
The term “overseas” as prescribed is limited to countries or regions other than Mainland China, Hong Kong and Macau.

四、曾為大陸地區人民具外國國籍且未曾在臺設有戶籍，申請時已連續居留海外 6 年以上，並符合下列規定者：

Individuals being former citizens of Mainland China and hold foreign nationality, having no history of household registration record in Taiwan, and at the time of application, has resided overseas for more than 6 consecutive years are qualified to apply for admission under these regulations.

(1) 所稱連續居留，指每曆年在國內停留期間，合計未逾 120 日。連續居留海外採計期間之起迄年度非屬完整曆年者，以各該年度之採計期間內在國內停留期間未逾 120 日予以認定。但符合第 2 款第五目第一小目至第四小目所列情形之一且具相關證明文件者，不在此限；其在國內停留期間，不併入海外連續居留期間計算。

The term “reside overseas continuously” mentioned in the preceding paragraph means an individual may stay in Taiwan for no more than a total of 120 days per calendar year. However, such a term may be exempt, if any of the conditions prescribed in Subparagraphs 1 through 4, Paragraph 5 of the previous Article applies and is supported with written proof, and the said domestic length of stay shall be excluded from the overseas length of residency.

(2) 所定 6 年，以擬入學當學期起始日期（2 月 1 日或 9 月 1 日）為終日計算之。

The six-year period shall be calculated using the starting date of the semester (Aug. 1st or Feb. 1st) as the designated end date.

(3) 所稱海外，指大陸地區、香港及澳門以外之國家或地區。

The term “overseas” as prescribed is limited to countries or regions other than Mainland China, Hong Kong and Macau

五、曾錄取並就讀國際專修部因故退學（含自行退學）之學生，不得再申請就讀新南向產學合作國際專班及國際專修部。

Students who were previously admitted and attended the International Program Division but later withdrew (including voluntary withdrawal) are not eligible to reapply for the New Southbound Industrial-Academic Cooperation International Program or the International Program Division.

Note : An individual eligibility is based on “Regulations Regarding International Students Undertaking Studies in Taiwan” announced by the Ministry of Education (<https://goo.gl/nVdEVV>). If the regulations are revised, the latest announcement from the Ministry of Education shall take precedence.

貳、語言能力 Language Proficiency

本專班申請入學時，建議申請者具備華語文能力測驗（TOCFL）A1 之能力，將予以優先錄取；未達此標準者，由本校以華語文能力快篩系統進行專業評估。凡能力低於 A2 之學生，須於入學後一年內通過 A2 檢定，以確保學習成效。

When applying for admission to this program, it is recommended that applicants possess TOCFL Level A1 proficiency. Such applicants will receive priority admission. Those who do not meet this standard will be professionally assessed by the university using the TOCFL Quick Screening System. Students whose proficiency falls below Level A2 are required to pass the Level A2 certification test within one year after enrollment to ensure learning effectiveness.

無論申請者是否具備華語文能力證明，申請者於註冊入學後須參加華語檢測，並依檢測結果分級輔導，本專班學生須於第一學年第二學期結束前通過華語文能力 A2 級以上（含）測驗，未能通過者，學校逕予退學。

Regardless of whether the applicant has proof of Chinese language proficiency, the applicant must take the Chinese language test after registration and receive graded counseling based on the test results. Students must attain Chinese language proficiency at level A2 or above before the end of the second semester of the first academic year. Those who fail to obtain the A2 certificate or above will be dismissed from the university.

參、學歷 Education

1.外國學生須符合教育部採認之高中、大學或獨立學院畢業者(請參考教育部國際及兩岸教育司網頁 <https://www.edu.tw/bicer/>)。申請本學士學位及副學士學位專班者須具國外高中畢業學歷。1.International students must have graduated from a senior high school, a university or an independent college recognized by the Ministry of Education (Please refer to the website of the Department of International and Cross-Strait Education, Ministry of Education <https://www.edu.tw/bicer/>). Applicants applying to this bachelor's degree and associate degree program must hold a foreign high school diploma.

2.具有教育部「入學大學同等學力標準」與我國學制相當之同等學力資格者。2.The applicants has the qualification to be equivalent to the academic qualifications of Taiwan's academic system based on “Equivalent Education Level for University Admission” regulated by Ministry of Education.

3.應屆畢業生申請時如尚未取得畢業證書，須先繳交「持臨時畢業證書申辦來臺就學居留簽證切結書」，如經錄取，須於開學註冊時或本校指定期限內繳驗經外館驗證的學歷證件正本，否則註銷其錄取資格。3.Graduates who have not yet obtained a graduation certificate when applying, must first submit the "Application Form for a Residency Visa to Study in Taiwan with a Provisional Graduation Certificate". If accepted, students must submit an application either during the admission registration process or within the time limit specified by the school. Additionally, they must submit the original academic certificate verified and stamped by the Taiwanese embassy abroad. Otherwise, the admission will be revoked.

4. 如申請人曾因學校操行、學業成績不及格或因犯刑事案件經判刑確定致遭退學，則不得申請入學。4.Applicants who have been expelled due to poor conduct, failing academic performance, or a confirmed criminal conviction are not eligible to apply for admission.

肆、學業成績規定(Academic Performance Requirement for Application)

本專班招收學生之學業成績規定為畢業平均成績達 6.0(含) 以上為原則。

Basically, the program requires Vietnam applicants to have GPAs of 6 or higher. The converted scores from other countries must be equivalent to a passing score of 6.0 or above (out of 100) in the home country.

伍、財力證明規定 (Financial Statement)

1.已獲獎助學金者，請提供政府、學校機關或民間機構獎學金證明。

Applicants who have already received scholarships must provide proof of scholarship from the government, school authorities or private institutions.

2.非獲得獎學金之申請者，須提供最近三個月內經由金融機構提出之中文或英文存款證美和臺幣 100,000 元以上（或美金 3,330 元）。

Applicants who have not received a scholarship must provide an official bank statement (in Chinese or English) that indicates an account balance of overNTD 100,000 (approximate USD 3,300). The statement must be issued by a financial institution within 3 months prior to application .

備註一：若存款證明非申請生本人帳戶或不足額，需另附資助者簽名之財力擔保書，敘明與申請者之關係，並保證負擔申請生在臺就學所有費用，

Note 1: If the proof of deposit is not the applicant's own account or is insufficient, a financial guarantee signed by the sponsor must be attached, stating the relationship with the applicant and guaranteeing that the applicant will pay all expenses for the student's study in Taiwan.

備註二：若存款證明之幣值非新臺幣或美金，申請生需自行於存款證明上註明匯率，並換算成相當於新臺幣或美金之總額。

Note 2: If the value of the deposit certificate is not in NTD or USD, the applicant must indicate the exchange rate on the deposit certificate and convert it to the total amount in NTD or USD.

備註三：財力證明須由銀行開立，不得由民間機構、公司或個人開立。

Note 3: The certificate of financial resources must be issued by a bank, not by a private organization, company or individual.

If the applicant has been enrolled, his or her student status shall be revoked and no relevant academic certificates shall be issued. If such cases are found out after graduation, their degree certificates must be cancelled.

1. 本校並未委託或授權其他單位或個人處理招生相關業務或收取任何費用。 Meiho University has not authorized or collaborated with any individual or unit for international student recruitment and fee collection.
2. 本校新南向國際學生產學合作專班申請由本校國際及兩岸交流處受理，就申請資格進行初審，初審合格者，則至招生國家進行面試複審，若因疫情等因素影響，則以視訊面試方式進行，面試通過名單，依本校程序通過錄取名單。The application for the university's New Southbound International Student Industry-Academic Cooperation Program is processed by the Office of International and Cross-Strait Affairs. The eligibility of applicants is initially reviewed, and those who pass the preliminary review will proceed to an interview and re-examination in the countries where they are applying. If affected by factors such as the pandemic, the interview will be conducted via video conferencing. The list of successful candidates will be admitted based on the university's procedures after passing the interview.

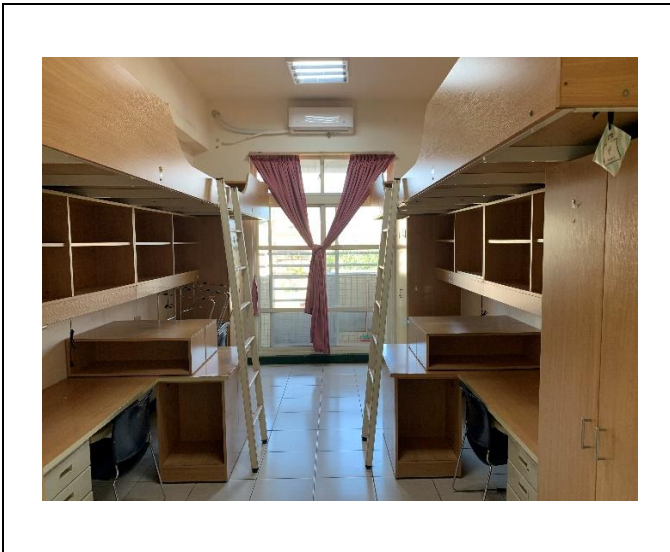

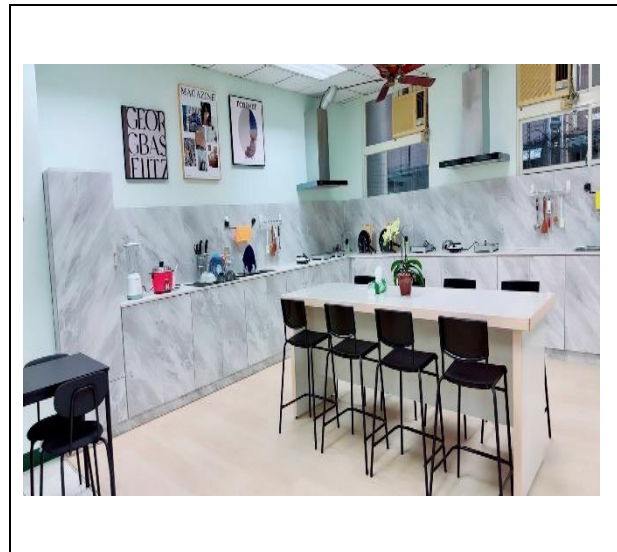
