申請資格 Eligibility

國籍 Nationality

1. 具越南國籍且未曾具有中華民國國籍，於申請時並不具僑生資格者。
An individual with Vietnamese nationality who has never held nationality status from the Republic of China (“R.O.C.”) and does not qualify as an overseas Chinese student at the time of their application
2. 具越南國籍且符合下列規定，於申請時並已連續居留海外(註 1)六年以上者。
An individual holding Vietnamese nationality who meets the following criteria and has resided continuously overseas for at least six years is also eligible to apply for admission under this regulation
 - a. 申請時兼具中華民國國籍者，應自始未曾在臺設有戶籍。
An individual who also holds citizenship of the R.O.C. should not have had household registration in Taiwan at any point
 - b. 申請前曾兼具中華民國國籍，於申請時已不具中華民國國籍者，應自內政部許可喪失中華民國國籍之日起至申請時應滿八年。
An individual who was also a national of the R.O.C. but does not have R.O.C. nationality at the time of their application shall have an annulled status regarding their R.O.C. nationality for no less than 8 years after an annulment of R.O.C. nationality by the Ministry of the Interior.
 - c. 前二款均未曾以僑生身分在臺就學，且未於當學年度接受海外聯合招生委員會分發。
Regarding individuals mentioned in the preceding 2 subparagraphs, they must not have studied in Taiwan as an overseas Chinese student nor received placement permission during the same year of the application by the University Entrance Committee for Overseas Chinese Students.
3. 具越南國籍，兼具香港或澳門永久居留資格，且未曾在臺設有戶籍，申請時於香港、澳門或海外連續居留(註 2)滿六年以上者。
An individual of the nationality of Vietnam, concurrently holding a permanent residence status in Hong Kong or Macao, having no history of a household registration record in Taiwan and, at the time of application, has resided in Hong Kong, Macao, or another foreign country for no less than 6 years is qualified to apply for admission under these regulations.
4. 曾為大陸地區人民具越南國籍且未曾在臺設有戶籍，申請時已連續居留海外六年(註 3)以上者。
An applicant being a former citizen of Mainland China and holds a nationality of Vietnam, having no history of household registration record in Taiwan, and at the time of application, has resided overseas continuously for no less than 6 years is qualified to apply for admission under these regulations.

註 1：所稱海外，指大陸地區、香港及澳門以外之國家或地區。

Overseas as prescribed in paragraph 2 and paragraph 3 is limited to countries or regions other than Mainland China, Hong Kong and Macao;

註 2：所稱連續居留，指外國學生每歷年在國內停留期間不得逾一百二十日。

The term “continuous residence” means that an individual may stay in Taiwan for no more than a total of 120 days per calendar year.

註 3：所定六年、八年，以擬入學當學期起始日（二月一日或八月一日）為終日計算之。

The periods of six and eight years are calculated from the start date of the semester in which the student intends to enroll (either February 1st or August 1st).

申請資格依據教育部『外國學生來台就學辦法』<https://goo.gl/kYHqPY>之規定。若規定有修改，以教育部最近期的公告為準。

An individual eligibility is based on “Regulations Regarding International Students Undertaking Studies in Taiwan” announced by the Ministry of Education (<https://goo.gl/nVdEVV>). If the regulations are revised, the latest announcement from the Ministry of Education shall take precedence.

語言能力 Language Proficiency

1. 本專班學生入學時，申請者華語文能力達 A1 級以上者(含)得優先錄取，惟若無法提出華測成績證明者，則須提出至少 60 小時以上(含)之華語研習證明。

Applicants whose Chinese proficiency reaches TOCFL A1 level or above (inclusive) will be given priority for admission. However, those who cannot provide TOCFL test score report or certificate must provide the certificate of at least 60 hours (inclusive) of Chinese language study.

2. 無論申請者是否具備華語文能力證明，申請者於註冊入學後須參加本校華語檢測，並依檢測結果分級輔導，本專班學生須於第一學年第二學期結束前通過華語文能力 A2 級以上(含)測驗，未能通過者，學校應逕予退學。

Regardless of whether the applicant has proof of Chinese language proficiency, the applicant must take the Chinese language test after registration and receive graded counseling based on the test results. Students must pass TOCFL A2 level or above before the end of the second semester of the first academic year. Those who fail to obtain the A2 certificate or above will be dismissed from the university.

學歷 Educational background

*1. 符合教育部採認之高中、大學或獨立學院畢業者(國際及兩岸教育司網站 <https://depart.moe.edu.tw/ED2500/Default.aspx>)。申請學士班者需具國外高中畢業或以上學歷。

Applicants who have graduated from a high school, college or university recognized by the Ministry of Education of Taiwan can apply for admissions (please refer to the website <https://depart.moe.edu.tw/ED2500/Default.aspx>). Foreign students with a foreign high school diploma or above are eligible to apply for undergraduate programs to obtain a bachelor's degree.

*2. 具有與我國學制相當之同等學力資格者。

Applicants with equivalent qualifications to the academic degree system of Taiwan can apply for admissions.

*3. 申請人畢業學校須為我國教育部認可或當地國政府權責機關或專業評鑑團體認可，符合教育部「大學辦理國外學歷採認辦法」(<https://goo.gl/29yeFG>) 規定之學校或我國政府立案之學校，否則恕不受理申請。

Those institutions from which applicants graduated must be accredited schools approved by the Ministry of Education of the R.O.C. as well as in accordance with the "Regulations Regarding the Assessment and Recognition of Foreign Academic Credentials for Institutions of Higher Education" <https://goo.gl/29yeFG>. Otherwise the application will not be accepted.

*4. 應屆畢業生申請時如尚未取得畢業證書，須先繳交「持臨時畢業證書申辦來臺就學居留簽證切結書」，如經錄取，須於開學註冊時或本校指定期限內繳驗經外館驗證的學歷證件正本，否則註銷其錄取資格。

Graduates who have not yet obtained a graduation certificate when applying, must first submit the "Application Form for a Residency Visa to Study in Taiwan with a Provisional Graduation Certificate". If accepted, students must submit an application either during the admission registration process or within the time limit specified by the school. Additionally, they must submit the original academic certificate verified and stamped by the Taiwanese embassy abroad. Otherwise, the admission will be revoked.

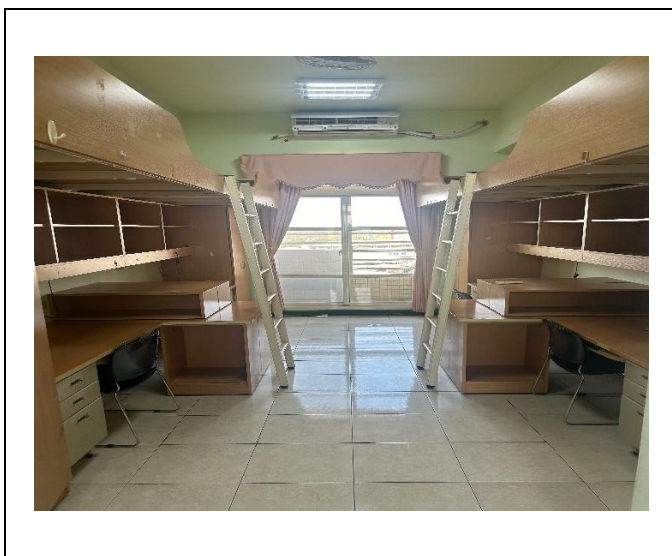
